3. **GEMPLER'S**, its owners, GHC Specialty Brands, LLC, and Reed-Joseph International Company shall not be held responsible for any injury resulting from the use or handling of these devices, whether or not used in accordance with the directions.
4. The buyer agrees to secure local and state use permits as required.
5. The buyer of explosive products must be 21 years of age or older.
6. The buyer hereby accepts said materials subject to all terms hereof.
7. Please be advised that all **GEMPLER'S** sales records for pyrotechnics and related shipping documents are available to and are subject to examination and review by Bureau of Alcohol, Tobacco, and Firearms-Department of the Treasury, United States Department of Transportation, and the U.S. Consumer Product Safety Commission.

I further understand that any other use of these items is **STRICTLY PROHIBITED BY LAW**.
