- 4. The buyer agrees to secure local and state use permits as required.
- 5. The buyer of explosive products must be 21 years of age or older.
- 6. The buyer hereby accepts said materials subject to all terms hereof.
- 7. Please be advised that all **GEMPLER'S** sales records for pyrotechnics and related shipping documents are available to and are subject to examination and review by Bureau of Alcohol, Tobacco, and Firearms—Department of Justice, United States Department of Transportation, and the U.S. Consumer Product Safety Commission.
